Credit Agreement

AUI as used in this credit agreement shall mean Allquip Universal Inc. dba Access Utilities International

1. _____ (The Customer) at _____ desires to purchase goods and services or to rent or lease equipment from AUI and agrees to be bound by the following terms and obligations.

2. Neither the Customer nor AUI shall have any obligation to purchase goods and services or to continue to rent or lease equipment or to sell or purchase or to continue to sell or purchase goods and services pursuant to this agreement.

3. Invoice will be mailed to the customer at the address set forth above by AUI and unless AUI is notified in writing of any error therein ten (10) days after the date of the invoice by Customer it shall be deemed to be correct and accepted as rendered. The Customer will pay to AUI the amount due as shown on the invoice net upon receipt. The Customer agrees to pay one and one-half percent (1 1/2%) per month (18% per annum) service / finance charge as shown on the invoice if or any portion not paid in 30 days. Service /finance charge may be avoided by paying the amount due within thirty (30) days after the date of the invoice. After invoices are ninety (90) days after the invoice date, a lien will automatically be served to companies holding payments to customers, unless Customer has made an arrangement with AUI. Customer shall be responsible for all legal expenses incurred by AUI in enforcing its rights under the Agreement.

4. The Customer agrees the payment for equipment rented, leased or purchased other than on an open account, shall be in accordance with the terms and conditions of the purchase and security agreements, rental, or lease agreement executed by and between Customer and AUI.

5. In the event AUI engages an attorney to enforce any of the obligations of the Customer, the Customer agrees to pay all costs of collection including but not limited to court costs and reasonable legal/attorneys fees, including the same on any appeal. Jurisdiction & Venue: The Courts of the State of California, and in and for the County of Yolo.

THE GOODS AND SERVICES SOLD PURSUANT TO THIS AGREEMENT ARE SOLD "AS IS" AND WITHOUT ANY WARRANTY WHATSOEVER, WITH THE SOLE EXCEPTION OF SUCH WRITTEN WARRANTIES, IF ANY, AS MIGHT BE DELIVERED TO THE CUSTOMER IN CONNECTION WITH ONE OR MORE PARTICULAR SALES OF GOODS OR SERVICES, EXCEPT FOR ANY SUCH EXPRESS WRITTEN WARRANTIES, ALL GOODS AND SERVICES SOLD PURSUANT TO THIS AGREEMENT ARE SOLD WITHOUT WARRANTY OF ANY NATURE WHATSOEVER, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE
